**Special Information:**

At its October 5, 2021, meeting, the Board of Supervisors adopted a resolution that, among other actions taken to comply with AB 361, directs all boards and commissions to continue to meet fully remotely (except quasi-judicial bodies that are already meeting in person for certain purposes). Therefore, at the direction of the Board, boards and commissions will only meet remotely and will not be able to meet in person at this time. The Board will periodically reconsider the state of emergency and whether fully remote meetings will continue pursuant to AB 361, and boards and commissions must accept the Board's findings as part of their meeting agenda in order to continue meeting remotely. The emergency directive suspending meetings of standing committees of boards and commissions will continue to be in effect until some time after the County resumes in-person meetings for boards and commissions.
